Greetings,

I'm pleased to announce that our long-awaited perimeter fence project is now complete. This project was made possible by a grant awarded to Congregation Emanu El by the State of California, designed to bolster security for synagogues like

ours. My thanks to Rabbi Cohn for pairing CEE with the grant writer and fence builder who made this project a reality. For some time now, we have had issues with trespassers coming onto our campus, leaving behind debris that compromised the safety and beauty of our synagogue home. There have also been instances of trespassers setting up tent encampments on our property. This fence, gate and campus-wide camera system will go a long way to solve these on-going issues. Please know that the front entrance gate will be open during regular temple business hours and during any and all temple events and worship services. If you need to access temple property during off hours, please contact the temple office ahead of time. Our private security detail will remain on duty during select events as well.

I'm also pleased to announce that our Rabbinic search committee has identified a potential candidate. Rabbi Jason Rosner has passed the initial screening of our committee and will be coming to our synagogue May 2-4. Rabbi Rosner will lead services on Erev Shabbat on May 2 and lead an adult education program on Saturday, May 3. On May 4, Rabbi will meet with parents and students from SJL as well as members of our Sisterhood. Please make yourself available to come to any and all events that weekend to meet Rabbi Rosner and ask any questions you might have. No final decision will be made until extensive vetting and background checks are conducted. If those hurdles are cleared the congregation will be assembled to issue a final vote.

Finally, on May 15 at 7:00 p.m., we will have our annual congregational meeting. This is the time when our congregants can learn the state of our temple and ask questions of our Board of Director members and clergy. I look forward to seeing all of you there.

Treasurer's Report



The approved final budget for Fiscal Year 2025/2026 has been approved by the Board of Directors and is published in our *Bulletin* in preparation for the formal presentation at the Congregational Annual Meeting on May 15th. (Please see the following page).

Thank you to our budget committee: Kathy Rosenfeld and Greg Weissman. I truly appreciate their help in preparing this budget.

Remember that a budget is a guideline, it is our best *estimate* of what we anticipate to receive in income and what we expect our expenses to be. As always, we do our best to limit our expenses wherever possible, while trying to increase revenues.

Below are a few key points about the Approved Final Budget:

INCOME:

- **Dues Income** We were successful in realizing the budgeted dues income for 24-25. The Board has approved a 5% dues increase. Our expenses have increased necessitating this increase.
- **High Holy Days** We will continue to charge for non-members attending High Holy Day Services.
- New Rabbi Funds are available from the Stanley Roshwald trust to fund a full-time Rabbi.

EXPENSES:

- Clergy Costs Total clergy costs include Cantor's contract and a full-time Rabbi.
- **Security** Our security costs have increased due to the need for additional security at all events.
- Utilities and Insurance Our insurance costs for Liability and Workers Comp has increased. Our water and electric costs have increased.

The Final Budget is not a balanced budget. The Board will be looking at additional funding sources throughout the year. A full budget presentation will be made at our Annual Meeting on May 15th at 7:00 p.m. I look forward to seeing you there!

Mommune 2

On a 2024 BBC program called "It Takes a Village," Lilla Benn, a young British university student, introduced a word most of us are unfamiliar with, "mommune." It means a group of single mothers and their children living together, supporting each other in practical terms and emotionally.

Lilla grew up in such an arrangement and thought it was great. Why didn't more single parents do this? Her curiosity led her to talk with others who had created mommunes and other similar family groups.

She talked with two women with four children between them in Texas. They each had left toxic relationships, one of them having no place to live after she left. Even though they hardly knew each other before, they were drawn together by their similar experiences. And one of them had extra space and invited the other to move in for a while. The 'little while' lasted, and after some time they decided to build little neighboring houses with their own hands, learning how on the job. They even would like to keep growing their mommune.

Lilla went to Paris and found an apartment building that is renting exclusively to single parents. The building brings the adults together in cooking, laundry, with play areas for the kids. Ten families are living there, all helping each other and creating a community of support and friendship. But not all the parents are moms. There's also one dad.

So, Lilla wanted to explore how men were finding co-parenting. Back in London she spoke with two men with two young children, a girl and a boy of the same age. Again the initial rooming together was expected to be temporary, but it just kept going on. One said it brought him "peace of mind" that "not all the responsibility is on your shoulders." Plus the little ones seem to love the arrangement, and the girl hoped they "would live together forever."

As recently our former Surgeon General Vivek Murthy stressed, parenting is hard, especially single parenting. We need others to help with the financial side of things, but mostly we need the person who will say, You look really tired. I'll look after your child while you have a nap. We need someone who shares these difficulties, both practical and emotional. We need companionship and support.

Once upon a time, we all lived with more than two generations in the same home. Grandparents provided active help and love. But in our more isolated society we are creating new ways of living. As one professional said, "Everybody needs a network." Communal living can be that essential help.
